A meeting with student participants and faculty advisors was held to discuss the nature of activities that the Corps would undertake.

He, then, invited comments from the group. The students responded enthusiastically and expressed an interest in getting started quickly.

Mr. Marash presented six specific projects for consideration, to illustrate the type of program that the students might pursue. In the ensuing discussion the students expressed a need for orientation and background in relation to an activity before they engaged in it. It was, also, suggested that the Corps could be divided into teams so that more than one project could be done at a time and students could have a choice to reflect their particular interests.

At the conclusion of the discussion the students expressed their interests, by a show of hands, as follows: Housing (a physical inventory of facilities and condition, sociological data, attitude survey) almost unanimous; Community Education (speakers bureau, radio program, public relations information) ten plus; Education (study centers, tutoring, evaluation of out of school programs to assist under-achievers, study of home background of under-achievers) seven; and Employment (racial census of work forces, survey of hiring and promotional policies and practices, in-service training programs, job assignments of minority group employees), two.

On the basis of this expression and with the consent of the students, it was agreed to present an orientation program on housing at the next meeting. Meanwhile, the students were urged to do some reading on the

subject in advance of the meeting.
